If Dankeschoen dies, is rendered unfit or otherwise unavailable to produce semen, Bluefields will provide frozen semen as an alternative. . Alternatively, the Breeder may choose frozen semen of Bluefields Berlin or chilled semen of Bluefields Floreno).

Change of mare: If the Mare described in this contract is no longer available or suitable for

breeding, a substitute mare owned or leased by the Breeder will be allowed.

Embryo transfer: If more than one pregnancy is achieved, additional pregnancy fees are

payable in accordance with the number of embryos recovered at a rate of

\$1'100.00.

Transport cost (if applicable):

Option 1: same day delivery to most Australian airports for \$275.00 +applicable airport flight cost. Transport costs from the receiving airport will be

at the expense of the Breeder.

Option 2: overnight shipping to most Australian areas available only to orders made between Monday and Thursday (cost depends on location and transport

company).

The container transporting the semen is the property of Bluefields and must be returned undamaged as soon as insemination occurs, or the semen is transferred to a veterinarian's storage facility, whichever occurs first, at the

Breeder's cost.
